**CARETAKER AGREES TO THE FOLLOWING TERMS AND CONDITIONS:**

\_\_\_ Caretaker represents that he/she has reasonable knowledge regarding the proper care and handling of dogs, specifically 'bully' type breeds.

\_\_\_ Caretaker acknowledges that his/her residence, if rented, permits pets and may be asked to produce a signed lease between caretaker and his/her landlord stating as such.

\_\_\_ Caretaker understands that the dog described above is entirely owned by TNF. By maintaining ownership of said dog TNF retains the right to examine, re-home and remove above stated dog at any time and for any reason. If said dog becomes lost or stolen, Caretaker agrees to notify TNF immediately. Caretaker also agrees not to sell, trade or dispose of this dog. If, at any time, Caretaker is unable or unwilling to care for this dog, Caretaker agrees to contact and return said dog to TNF. Caretaker understands that said dog might then be placed in a new foster home, in a boarding facility, or be euthanized if no other solution is found.

\_\_\_ Caretaker agrees that said dog will not be used for any illegal purposes and will NEVER be fought in any way. If this clause is broken, Caretaker understands that the dog will be immediately confiscated by TNF and all law enforcement agencies will be notified, as applicable.

\_\_\_ Caretaker hereby agrees to care for this dog humanely (including providing adequate food, water, shelter, love and attention). Said dog shall be maintained in an adequate and safe enclosed area or on leash at all times. Dog is to be kept inside the house when home alone and never be left unattended outside. Caretaker must separate foster dog from other animals in their possession when caretaker is away from home.

\_\_\_ Proper separation includes keeping each animal in its own crate and/or secluded in a secured area in caretaker's home. Foster dogs are to be supervised at all times, whether indoors or outdoors. Foster dogs must be supervised at all times when children and other animals are present. Dog shall not be allowed to roam at will or at large. In addition and accordance to TNF policies the Caretaker agrees to crate train said foster dog. At no time will any TNF foster dog be able to attend "leash free dog parks", whether on leash or otherwise. Within the province of Ontario all Caretaker will comply fully and completely to the Dog Owners Liability Act.

\_\_\_ Should caretaker require an outside party to temporarily care for said foster dog, TNF must be notified in advance of temporary caretaker taking possession of said dog. If TNF feels that the temporary caretaker is not suitable, TNF shall take possession of said foster dog until such time as caretaker can resume full care.

\_\_\_ Caretaker agrees and understands that any veterinary care required for the above describe dog will be provided by an TNF approved veterinarian ONLY. In such cases where emergency veterinary care is required the fosterer agrees to contact an TNF representative as soon as possible. If unable to reach TNF, only the basic stabilizing care is approved until TNF speaks to the veterinarian. If fosterer takes the dog to a veterinarian for a non emergency situation, expenses will not be covered unless pre approved. All foster dogs will be vaccinated annually with necessary inoculations (DH2PP) and vaccinated against rabies, as local ordinances require. All foster dogs will be dewormed.

\_\_\_ Caretaker agrees to notify TNF within 24 hours of any change of address or phone number. It is also understood that a representative of TNF may examine and make inquiries about said dog at any time. If not satisfied with the condition of the dog or the conditions in which it is kept, said dog can or may be removed immediately and placed in a different foster home. Any veterinary services needed due to negligence or lack of care will be the responsibility of Caretaker and payable to TNF.

\_\_\_ Caretaker understands that TNF makes no guarantees or warranties regarding the health and/or temperament of this dog. Caretaker understands that TNF is not responsible for any damage caused by said foster dog to caretaker's property or possessions. Caretaker promises and agrees to be solely responsible for this animal while in Caretaker's care and to indemnify and hold harmless TNF and/or TNF representative from any and all claims of liability for the conduct of this animal on or

after the date of this foster agreement. This Release of Liability and Indemnification shall apply to all known, unknown and unanticipated damages resulting from my/our foster or control of such animal.

\_\_\_Furthermore Caretaker agrees to contact an TNF representative immediately should any behaviour or temperament traits arise which would be of concern. These traits may be, but are not limited to; aggression/intolerance towards people; aggression/intolerance toward other domestic animals; signs of shyness, fearfulness or lack of confidence in new situations; resource guarding; separation anxiety.

\_\_\_Caretaker understands that the responsibility of screening and placement into permanent adoptive homes falls strictly and only on TNF representatives. At no time will the Caretaker be required to communicate with adoptive applicants nor will contact information of any parties be disclosed, unless agreed upon beforehand. Caretaker shall make said foster dog available for any pre approved prospective adopter at a mutually convenient time and location. Furthermore Caretaker agrees that any publicity, posting on public forums or internet sites or any other means of increasing adoption interest in the foster dog is the sole responsibility of TNF representatives and actions taken to increase such interest by the Caretaker must have consent from a TNF representative.

\_\_\_Any items borrowed from TNF such as crates, etc. must be returned to TNF when Caretaker ceases fostering for TNF.

\_\_\_Caretaker understands that no personal contact information of any TNF representative shall be transferred without explicit consent. Likewise TNF agrees to hold Caretaker's personal and contact information in strict confidentiality.

**CARETAKER HEREBY ACKNOWLEDGES THAT HE/SHE HAS READ AND UNDERSTANDS THE ABOVE TERMS AND CONDITIONS AND WILL KEEP THE DOG DESCRIBED HEREIN AS A FAMILY MEMBER UNTIL A PERMANENT HOME IS FOUND BY TNF OR ALTERNATE HOUSING ARRANGEMENTS ARE MADE.**
